

EasyPay Everywhere Love to Swipe & Win

1. Terms and Conditions

- 1.1. If you choose to enter the *EasyPay Everywhere Love to Swipe & Win Competition* (the “**Competition**”) you acknowledge and agree that the rules, as set out in these Terms and Conditions (the “**Terms and Conditions**”), are binding and enforceable on you.
- 1.2. EasyPay Financial Services Proprietary Limited will be referred to as the “**Promoter**” in respect of the Competition and in these Terms and Conditions.
- 1.3. **Mastercard Inc.**, (“**Mastercard**”) is working with the Promoter for the purposes of this Competition.
- 1.4. The Competition will run from **1 February 2026** and ends at midnight (12am) on **30 April 2026**, both days inclusive (the “**Competition Period**”).

2. The Prize

- 2.1. The total value of all Prizes to be awarded throughout the Competition Period is R100,000.00 (one hundred thousand Rand) (collectively, the “**Prize**”).
- 2.2. 10 (ten) qualifying winners will be randomly selected each month during the Competition Period to receive a cash prize of R2,500.00 (two thousand five hundred Rand), which will be paid into their EasyPay Everywhere account (the “**Cash Prize**”).
- 2.3. In addition, 1 (one) winner will be randomly selected at the end of the Competition Period to receive a grand prize consisting of R20,000.00 (twenty thousand Rand) paid into their EasyPay Everywhere account and a R5,000.00 (five thousand Rand) grocery voucher (the “**Grand Prize**”).

3. To qualify to enter the Competition

In order to be eligible to enter into the Competition, entrants must:

- 3.1. be a permanent resident and/ or citizen of the Republic of South Africa;
- 3.2. have a valid South African identity number;
- 3.3. be 18 (eighteen) years or older;
- 3.4. have an active EasyPay Everywhere account which is not in default; and
- 3.5. receive their grant into their EasyPay Everywhere account for at least 1 (one) month prior to the Competition Period;
- 3.6. swipe their EasyPay Everywhere card at any participating retail store for a minimum of R50.00 (Fifty Rand) or more during the Competition Period.

4. How the Competition will run

- 4.1. Entrants will earn 1 (one) entry for each in-store purchase of R50.00 (Fifty Rand) or more. The entrants name and details will automatically be entered into the Competition.
- 4.2. Entrants may earn a maximum of 20 (twenty) entries into the Competition.
- 4.3. Ten (10) Competition winners will be randomly selected from all entrants at the end of each month during the Competition Period.

4.4. One (1) Competition winner will be randomly selected from all entrants at the end of the Competition Period to win the Grand Prize.

4.5. If you are a Competition winner:

4.5.1. you will be contacted personally using your contact details that the Promoter has on record before the Competition winners are publicly announced. The Promoter will take all reasonable measure to contact you, however, if the Promoter is unable to contact you after 3 (three) attempts over 2 (two) days, a new Competition winner will be randomly selected. For the avoidance of doubt, missed calls and calls diverted to voice mails will not be considered as answered for purposes of this Competition;

4.5.2. it is your responsibility to ensure that any information which you provide to us is accurate, complete, and up to date. Should any of the data provided by yourself in connection with this Competition prove to be invalid, inaccurate, false, or misleading, your entry shall be disregarded unless such data is updated prior to the end of the Competition Period;

4.5.3. you will receive the Prize within 30 (thirty) calendar days after the public announcement by the Promoter;

4.5.4. you must provide your proof of identity (original not copies) in person, which aligns with the information the Promoter has on record, in order to claim the Prize; and

4.5.5. you consent that your full name and photo may be used and published on all selected communications, media and social media platforms, unless you advise the Promoter in writing that you do not want to have your name and photo used and published on all social media platforms.

5. **Prize Conditions and Restrictions**

5.1. The Promoter does not make any representations or warranties to you, whether expressly or implicitly, that the Prize will meet your requirements, preferences, standards or expectations or be satisfactory.

5.2. You cannot transfer, defer, change or exchange the Prize for any other item or for cash.

5.3. If you do not meet all the requirements to be eligible to enter this Competition, then you will forfeit the Prize if you are selected as a Competition winner.

5.4. Failure to provide the necessary proof of identification will result in you forfeiting the prize.

5.5. Winners who have been awarded the cash prizes during the competition period will not be eligible to win another prize for the Competition Period.

6. **General terms**

By entering this Competition or accepting the prize, you understand that:

- 6.1. The Promoter and/or Mastercard will interpret these Terms and Conditions in its sole discretion and reserve its rights to change these Terms and Conditions at any time.
- 6.2. You consent to the Promoter and/or Mastercard sharing your personal data in accordance with the Protection of Personal Information Act, 4 of 2013 (“**POPI Act**”) with our affiliates in South Africa such as any entity controlling or controlled by the Promoter for purposes of the Competition.
- 6.3. You agree and consent that the Promoter and/or Mastercard may collect and process your personal information for purposes of this Competition in compliance with the POPI Act.
- 6.4. The Competition winners will be requested to be part of marketing and promotional activities, including social media posts, for which no fee, royalty or other compensation will be payable. Competition winners have the right to decline consent or participation in the marketing and promotional activities.
- 6.5. The Promoter and/or Mastercard, its directors, members, partners, employees, agents, consultants, suppliers, any other person or entity, who is directly or indirectly under its control, or any supplier of goods and services in connection with this Competition and their spouses, life partners, parents, children, siblings, business partners or associates are not eligible to participate in or enter this Competition.
- 6.6. EasyPay Everywhere accountholders who have been awarded a prize for any Competition within the last 3 (three) months are not eligible to participate in or enter this Competition .
- 6.7. You irrevocably agree to indemnify, release and hold harmless the Promoter and/or Mastercard (including their subsidiaries, holding companies and affiliates), its directors, employees and agents from and against any legal actions, claims, costs and/ or liability for injury, all loss, damage or expenses of which you may suffer, resulting in whole or in part, directly or indirectly, from participating in the Competition, and/ or the use, acceptance or possession of the prize.
- 6.8. The Promoter and/or Mastercard reserves the right to vary, postpone, suspend, or cancel the Competition and any Prize, or any aspect thereof, for any reason which we deem necessary, on reasonable notice to you, save where such changes are immaterial and of no effect to you. In the event of such variation, postponement, suspension, or cancellation, you agree to waive any rights, interests, and expectations that you may have in terms of this Competition and acknowledge that you will have no recourse against us.
- 6.9. The Promoter and/or Mastercard its affiliates will not be responsible for any harm, damage, loss, or claim relating to the provision of any element of the Prize or any changes to the Prize that may be made at any time.
- 6.10. You agree that your participation in the competition, and your acceptance and/or use of the Prize, or any aspect thereof, is at your own risk.

- 6.11. These terms and conditions will be construed, interpreted, and enforced in accordance with the laws of contract and dispute resolution in the Republic of South Africa.
- 6.12. The Promoter and/or Mastercard is not liable for any technical failure that may result in you not being successfully entered into the Competition.
- 6.13. If the Promoter and/or Mastercard finds that you have acted unlawfully, fraudulently, dishonestly or in breach of these Terms and Conditions you will be disqualified from participating in the Competition and you will forfeit any prize if you are a Competition winner.
- 6.14. The Promoter and/or Mastercard reserves the right to terminate the Competition at any time by giving 14 days' notice. If this is the case, the Promoter will provide a notice on the EasyPay Everywhere website as well as on its social media platforms and you are responsible to review the website in this respect. You also waive any rights which you may have against the Promoter and acknowledge that you will have no legal recourse and/ or claim of any nature against the Promoter in this regard.
- 6.15. The Competition period may also be extended or shortened at the discretion of the Promoter and/or Mastercard. If this is the case, the Promoter will provide notice of this on the EasyPay Everywhere website.
- 6.16. An independent registered auditor appointed by the Promoter and/or Mastercard will oversee and certify the manner in which the Competition is conducted.
- 6.17. The Competition will be managed in accordance with the provisions of the Consumer Protection Act, 68 of 2008 (“CPA”) and nothing in these Terms and Conditions is intended to, or must be understood to, unlawfully restrict, limit or avoid your or the Promoter’s rights or obligations under the CPA.
- 6.18. These Terms and Conditions shall be governed by the laws of the Republic of South Africa.
